OTHER RELEVANT INFORMATION

Regarding the liquidity contract signed with JB Capital Markets, Sociedad de Valores, S.A.U., (the “**Liquidity Contract**”) initially signed in July 2019 (communicated to the market through the publication of the corresponding “relevant fact” registration number 280677) and which has been extended by agreement between the parties successively, the last in July 2023 (effective until July 11, 2024), communicated on July 17, 2023 (registration number 23629), and in accordance with the provisions set forth in Rule Fourth, limb 2, b) of Circular 1/2017 of 26 April, of the Spanish National Security Market Commission (*Comisión Nacional del Mercado de Valores*) on liquidity contracts, a summary of the operations carried out under the aforementioned Liquidity Contract for the first quarter of the fiscal year of 2024 (since 1 January 2024 until 31 March 2024) is hereby included.

It is hereby stated that, between March 12, 2024 and March 18, 2024 (both inclusive), the Liquidity Contract was temporarily suspended in order to not alter, through variations in treasury shares, the calculation of the pre-emptive subscription rights required to subscribe convertible notes in the framework of the public subscription offering of subordinated notes mandatorily convertible into newly issued ordinary shares of the Company announced to the market on March 12, 2024.
